The tour will include visits to various types of agritourism enterprises in Tennessee, Kentucky and Indiana over the course of three days. Time on the bus will be spent networking with other participants.

## Eligibility Requirement:

- Applicants must be operators of an existing Tennessee agritourism enterprise or Tennessee farmers planning to start a new agritourism enterprise.

**Tour Dates:** November 11-13, 2008

**Start/End Location:** Ellington Agricultural Center, Nashville, TN

## Registration Fee: \$200

- The registration fee is to be submitted upon notification of selection – not with application.
- The registration fee is an eligible expense for cost-share reimbursement under the Tennessee Agricultural Enhancement Program (TAEP) with an approved TAEP Producer Diversification Cost-Share Application.
- The registration fee includes transportation, two nights hotel (double occupancy), meals, refreshments, educational tours and materials during the event.
- Participants are responsible for their own travel arrangements and expenses to and from Ellington Agricultural Center in Nashville.

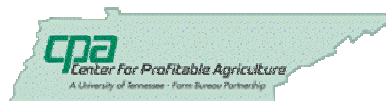
